DOCUMENTATION

- a) Copy of the Citizenship Card or Passport
- b) Color copies of diplomas: performance degrees, Bachelor of Music, Master's Degree or other related university musical degrees, must be registered in the SENESCYT (Secretaría Nacional de Educación Superior, Ciencia, Tecnología e Innovación). In the event that the selected candidate is a foreigner, he/she will register with the SENESCYT, once he/she is in Ecuador. All documentation must be legally translated and apostilled in his or her native country, prior to arriving in Ecuador.
- c) Letter of application
- d) Artistic dossier that accredits your experience
- e) Three professional references
- f) Detail of professional experience in area of expertise

AUDITION COMMITTEE

- a) The Audition Committee is constituted as follows:
 - Music Director of the OSNE
 - · Co-concertmaster of the OSNE
 - A delegate from the OSNE appointed by the Music Director

The Music Director will be the Chairman of the Committee and will have the casting vote. He may count upon the collaboration of an external advisor without a vote, in order to advise on technical aspects in the decision-making process.

The Administrative and Human Talent Director or his delegate will act as Secretary.

- b) All the members of the Committee will have voice and vote with the exception of the Secretary.
- c) In the event that a member of the Committee is related to any of the candidates, up to the second degree of consanguinity or affinity, they will notify the OSNE Music Director immediately, recusing hi or herself from the Committee, not intervening in any way in the deliberations over the specific applicant.
- d) The Audition Committee may not be constituted or act without the presence of more than half of its members.

EVALUATION AND INTERVIEW PROCESS

Interviews will be held in person or via Zoom on April 17, 2023, at the OSNE offices and at a time to be coordinated in advance with each selected applicant.

- a) The interviews and sight reading for foreigners will be carried out via Zoom in accordance with this announcement.
- Qualification:

Applicants will be graded from 0 to 100 points, excluding those applicants who score less than 60 points. In the event of a tie between two or more applicants with the highest score, the casting vote of the President will apply.

Audition process:

The auditions will be carried out interpreting obligatory works and orchestral repertoire in accordance with the provisions of the Committee. Likewise, the Committee may ask applicants to sight-read orchestral excerpts from the standard symphonic repertoire.

· General conditions:

The Committee may, at any time during the audition of a candidate, terminate the execution of the interpretation of a work or fragment.

The use or mere display of mobile phones, or any other telecommunication device within the premises where the auditions take place, is absolutely prohibited.

Obtaining a certain score as a result of an audition does not obligate the OSNE to proceed in contracting the candidate.
