

# INTERNATIONAL VIOLIN COMPETITION CONVIMUS-GOROHOV

## **REGULATION**

The present regulation establishes the terms and conditions for the International Violin Competition CONVIMUS - GOROHOV, integrated in the International Music Festival in Oporto CONVIMUS, co-produced by the association AMASING in partnership with the association NEW VIBRATIONS.

All participants accept that the present Regulations may be altered at any time and without prior notice, whenever justified by force majeure. In this case, the festival may adjust the format and rules of participation in the event in order to guarantee the health and safety conditions of all participants and other participants.

## Article 1

## **DESCRIPTION**

In the year 2023, the AMASING association and the NEW VIBRATIONS association, in close collaboration with the Parish Councils of Aldoar, Foz do Douro and Nevogilde, promote the international violin competition integrated in the Oporto International Music Festival, CONVIMUS-GOROHOV, aiming at promoting the international careers of the young participants. This competition was created with the purpose of giving opportunities to young national and international artists.

The closing date for registration is 25th June 2023.

### Article 2

# **OBJECTIVES OF THE COMPETITION**

The objectives of the Oporto International Violin Competition are:

- 1. to motivate and encourage all students for the positive study of music.
- 2. To promote artistic merit and individual effort.
- 3. To enhance the educational dimension and motivate teachers for teaching.
- 4. To create and promote national and international careers for participants.
- 5. To promote Networking, the creation of international links.
- 6. To promote conviviality, well-being and good relations between participants.
- 7. To create opportunities for further learning and diverse experiences.
- 8. To promote physical, intellectual, and social accessibility to artistic opportunities.
- 9. To promote audience creation and awareness of the arts.
- 10. Enhancement and promotion of national heritage.
- 11. supporting and promoting Ukrainian artists, young and established.



# **ELIGIBILITY OF CANDIDATES**

- 1. Young people with NO AGE LIMITATION can apply to the International Violin Competition.
- 2. In the case of minors under 18 years old on the date of the competition, it will be necessary to present a written authorization from their Parents or Guardians.

### Article 4

## **CATEGORIES AND PROGRAMME**

# **CATEGORY A**

- c. Choice of one compulsory pieces: (to be downloaded from site).
  - 1. Paganini Adagio (unpublished)
  - 2. Myroslav Skoryk Spanish Dance
- d. Maximum duration is 25 minutes.

## **CATEGORY B**

- a. Up to 18 years old.
- b. Single Test: Two or more pieces of contrasting period and/or character.
- c. Choice of one compulsory pieces: (to be downloaded from site).
  - 1. Luís de Feitas Branco: Praeludium for violin and piano
  - 2. Fritz Kreisler: Praeludium and Allegro
- d. Maximum duration of 20 minutes.

# **CATEGORY C**

- a. Up to 14 years old.
- b. Single Test: Two or more pieces of contrasting character.
- c. Choice of one compulsory pieces: (to be downloaded from site).
  - 1. Fritz Kreisler: Liebeslied
  - 2. Tomas de Lima: Serenada ob. 36
- d. Maximum duration of 17 minutes.

## **CATEGORY D**

- a. Up to 10 years old.
- b. Single Test: two or more pieces of contrasting character.
- c. Strong suggestion / optional piece: (to be downloaded from the site).

Kuchler's Concertino op.15 1st movement and/or 2nd and/or 3rd movement (It is intended that all participants who have the piece prepared can play with António Fragoso Orchestra, the first and/or second and/or third movement on Saturday 29th July).



- d. Maximum duration is 15 minutes.
- 2. The organisation is not responsible for the non-use of original scores or the sending of uncomplete scores.
- 3. The programmes to be presented by the candidates cannot be changed after the 1st of 1 July 2023.

## **REQUIREMENTS**

The application shall include the following documents:

1. A Curriculum Vitae or Biographical Note containing personal, scholastic and extra-scholastic information

or extracurricular information, such as the applicant's musical background, teachers, masterclasses, competitions, or relevant information.

- 2. Passport size photo (clear).
- 3. Photocopy of the Identity Card or Citizen Card.
- 4. Proof of qualifications, or a document that irrefutably proves the year of schooling. If this is not possible at the time of application, the document must be presented on the date of the respective eliminatory round, when requested by the entities that regulate the competition.
- 5. Program to be presented and its duration.
- 6. Scores of the solo part and piano accompaniment in digital format.
- 7. Other information considered important.

## **SUBMISSION OF APPLICATIONS**

- 1. Applications must be submitted digitally, along with the appropriate piano scores, **NO LATER than 25 JUNE** at the latest, using the form presented on the website www.convimus.com .
- 2. The submission will only be considered after the payment of the registration fee and the proof of payment to the email convimus.gorohov@gmail.com
- 3. Confirmation is made through the same email, within 2 working days.
- 4. In the event of a high turnout, the promoter reserves the right to pre-selection of the candidates by order of registration.

### Article 8

# PIANO ACCOMPANIMENT

- 1. The Pianist Accompanist is provided by the festival, for those who wish it.
- 2. Each candidate will have a rehearsal with a pianist assigned by the organization **IF THE SCORE IS SENT ON TIME** Each candidate will have a rehearsal with a pianist assigned by the organization with a minimum duration of the time of the competition of the respective category. the pianist's good sense to distribute the time according to the difficulty and duration of the works.

## Article 9

# **STRUCTURE OF THE COMPETITION**

- 1. all participations are public and will take place in the main auditorium of the University Lusíada do Porto.
- 2. The participants will perform in alphabetical order within the level they are competing for.
- 3. Participants must present themselves one hour before the beginning of the competition in their with their citizen card.
- 4. The more detailed calendar of the competitors will be presented on the website at the latest by the end of July 15th and sent by email to each of the candidates, with time and place of the rehearsal and competition of the different classes, through the e-mail in the registration form.



## PROGRAM OF THE COMPETITION

- 1. The programme of the competition may be consulted on the event's web page: www.convimus.com
- 2. The organisation reserves the right to change the programme without prior notice, until the beginning of the event, and must always communicate such fact to the participants, in writing.

### Article 11

### **JURY**

- 1. The jury of the competition is designated by the promoting entity AMASING and NEW VIBRATIONS and is composed of five people, being four international personalities of recognized merit in the area of music, as effective members.
- 2. The jury will be presided by the notable personality OLE BOHN.
- 3. The jury can only deliberate when the number of members present at the meeting corresponds to the number of effective members, except for the circumstances described in point 9 of this same article.
- 4. The jury deliberations, which must always be grounded, shall be made by majority of votes. In the event of a tie, the President of the jury panel shall have the deciding vote of the panel of jurors.
- 5. The jury reserves the right to interrupt the performance of each candidate, should it the jury reserves the right to interrupt the performance of each candidate, if it deems it opportune.
- 6. The jury will consider in its score the performance of the works from memory, with the exception of the sonatas for violin and piano.
- 7. The jury reserves the right not to award any of the prizes and its decisions are sovereign. Honourable Mentions may be attributed to the competitors as the jury sees fit.
- 8. The right not to attribute any prize is reserved to the jury.
- 9. In exceptional cases where the competitor is a student of one of the members of the jury that juror will be excluded from the evaluation of the same candidate.

### Article 12

## **AWARDING OF PRIZES**

- 1. All the competitors will have an individual opinion from each of the juries about possible musical, technical and performing parameters to be improved.
- 2. All competitors will receive a Participation Diploma.



- 3. The absolute winners in categories A, B and C will play the respective the António Fragoso Orchestra at the final concert on 29th July 2023.
- 4. In category D, all students who have prepared the Kuchler Concertino, 1<sup>st</sup> and/or 2<sup>nd</sup> and/or 3<sup>rd</sup> movement, will play with the Antonio Fragoso Orchestra on Saturday the 29<sup>th</sup> of July.
- 5. The competition organisation has the possibility of increasing the value of the prizes and the number of prizes, if it so wishes.
- 6. In all categories, diplomas will be awarded to all participants, of gold, silver diplomas will be awarded to all participants, according to the jury's final average score.
- 7. In categories A, B and C, 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place diplomas will be awarded, up to a maximum of 5 elements in total. There will be no 1st prizes ex-aequo. There may be Honourable Mentions.

- 4. The organization may make, for registration and/or divulgation purposes, audiovisual audiovisual recordings of the competitors' tests and other presentations integrated in the competition.
- 5. It is expressly forbidden for the public or participants to record or take photographs during the competition.
- 6. Registration in the CONVIMUS GOROHOV 2023 International Violin Competition implies the cession of audiovisual rights of the candidate.

## **EXCLUSION CRITERIA**

- 1. Any application made after 25 June 2023 will not be accepted.
- 2. The organising team reserves the right to exclude any participant in the event of inappropriate conduct to the event.
