



# RULES AND REGULATIONS OF PRIMUZ INTERNATIONAL STRINGS COMPETITION

## §1.

1. PRIMUZ INTERNATIONAL STRINGS COMPETITION is organized by the Primuz Foundation based in Łódź.
2. The Competition will be held on the basis of video recordings, submitted via YouTube.

## §2.

1. The Competition is intended for violinists, violists, cellists and double bassists.
2. Contestants will be evaluated according to four age categories:

### A: Violin

- Cat. I: born between 1.01.2010 and 31.12.2014 - free program up to 10 minutes;
- Cat. II: born between 1.01.2005 and 31.12.2009 - free program up to 12 minutes;
- Cat. III: born between 1.01.2000 and 31.12.2004 - free program up to 15 minutes;
- Cat. IV: born before 31.12.1999 - free program up to 20 minutes.

### B: Viola

- Cat. I: born between 1.01.2010 and 31.12.2014 - free program up to 10 minutes;
- Cat. II: born between 1.01.2005 and 31.12.2009 - free program up to 12 minutes;
- Cat. III: born between 1.01.2000 and 31.12.2004 - free program up to 15 minutes;
- Cat. IV: born before 31.12.1999 - free program up to 20 minutes.

### C: Cello

- Cat. I: born between 1.01.2010 and 31.12.2014 - free program up to 10 minutes;
- Cat. II: born between 1.01.2005 and 31.12.2009 - free program up to 12 minutes;
- Cat. III: born between 1.01.2000 and 31.12.2004 - free program up to 15 minutes;
- Cat. IV: born before 31.12.1999 - free program up to 20 minutes.

### D: Double bass

- Cat. I: born between 1.01.2010 and 31.12.2014 - free program up to 10 minutes;
- Cat. II: born between 1.01.2005 and 31.12.2009 - free program up to 12 minutes;
- Cat. III: born between 1.01.2000 and 31.12.2004 - free program up to 15 minutes;
- Cat. IV: born before 31.12.1999 - free program up to 20 minutes.

3. There is no age limit in the Category IV.
4. The Competition is open for instrumentalists of all nationalities meeting the age requirements from §2 point 2.

### §3.

1. The requirement for participating in the Competition is sending all of the following documents till 30.06.2021, 23:59, to the email address primuzcompetition@gmail.com:
  - completed and signed Application Form,
  - link(s) to YouTube videos,
  - copy of one of the following document confirming the age of the Competitor (identity card/passport/student card/birth certificate) - include only the page of the personal document which enables the Organizers to verify the age and identity of the Competitor,
  - copy of the payment confirmation.
2. The entry fee is as follows:
  - 200 zł - for contestants from Poland;
  - 50 € - for contestants from abroad.
3. The payment should be made until 30.06.2021 on the bank account:

or by PayPal to the e-mail address: primuzfoundation@gmail.com. There is 3% commission on PayPal payments (6 zł/1,5€).

4. The title of the bank transfer should include: Primuz International Strings Competition and name and surname of the Competitor.
5. All bank transfer fees are to be paid by the contributor.
6. The payment is non-refundable.

### §4.

1. The Participant is required to send one or more links to video recordings placed on YouTube. The total time of all submitted videos per Participant should not exceed the limits set in §2 point 2.
2. The title and description of every video must contain: PRIMUZ INTERNATIONAL STRINGS COMPETITION, name and surname of the Competitor, date of birth, category, instrument and performed program.
3. The videos should be made after 1.01.2020.
4. The performance should be in good quality and present the Competitor in a way that enables them to be identified. The recording must be made from one camera. Any editorial process of sound or image is forbidden.
5. It is possible to record the pieces separately (parts of cyclic works). The access to the videos should be granted throughout the entire Competition.
6. The Organizer reserves the right to reject the videos not meeting the criteria above.
7. The Participants agree to the free of charge and unlimited usage of their videos for promotion and advertising purposes.

### §5.

1. The Organizers provide for granting the Grand Prix of 1000 zł. The Grand Prix laureate will also be awarded a solo concert with PRIMUZ Chamber Orchestra (<https://www.facebook.com/primuzchamberorchestra>).

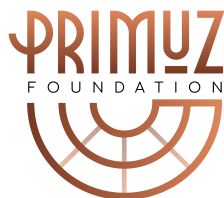
2. The financial prize pool is 7000 zł.
3. Financial prizes will be awarded for Grand Prix laureate as well as first prize winners in each category. Jury can also award special prizes.
4. Awards and honorable mentions winners receive the title of the Laureate of Primuz International Strings Competition.
5. Diplomas of participation as well as for laureates will be delivered via email.

#### §6.

1. The Competitors will be evaluated on basis of the individual rules and regulations for the Jury, enacted at the beginning of the evaluation process.
2. The score of every participant is the result of the arithmetic mean, based on each jurors' mark.
3. Jury reserves the right not to award a prize in case of the low score of the winner.
4. The decisions of Jury are final and unactionable.
5. The results will be published on the website [https://www.facebook.com/Primuz-International-Strings-Competition-100998868793907/?ref=page\\_internal](https://www.facebook.com/Primuz-International-Strings-Competition-100998868793907/?ref=page_internal) till 10.07.2021. Laureates will also be informed by email.
6. In case of a large number of entries the Jury can delay the results announcement for a few days.

#### §7.

2. The Organizers reserve a right to make changes in the Rules and Regulations.
3. Due to the reasons beyond the Organizers' control, the Competition may be cancelled. If so, the entry fee will be returned.
4. In a matters not governed here, the provisions of the Civil Code shall apply.

## INFORMATION CLAUSE FOR A PERSON, WHOSE PERSONAL DATA IS BEING PROCESSED ACCORDING TO A SIGNED CONSENT

On the basis of the art. 13 of the GDPR we would like to inform that:

1. The Administrator of your personal data included in the application form for the PRIMUZ INTERNATIONAL STRINGS COMPETITION is the 'Primuz' Foundation based in Łódź, Gdańska 116 Street, u. 36. In order to exercise your legal rights in accordance with the GDPR, including the withdrawal of the consent it is necessary to send the appropriate statement to the Foundation's email address: [primuzfoundation@gmail.com](mailto:primuzfoundation@gmail.com)
2. The personal data will be processed only to implement the provisions of the Rules and Regulations of the Competition.
3. Including your personal data is obligatory to take part in the Competition as well as for the proper conduct of the Competition.
4. The data can also be processed in connection with the redress/defense of claims on the basis of the legally justified interest of the Administrator (art.6 act 1 l. f GDPR).
5. You are entitled to gain access to your personal data, rectify, delete or limit its processing, object to its processing and you have the right to transfer the data.
6. You have the right to withdraw any consent you have made in any time. The withdrawal does not affect the compliance with the law of the processing that had been executed before the withdrawal.
7. Your personal data will be processed for no longer than three months after the end of the Competition.
8. The data in a form of scan of the personal documents will be deleted immediately after the verification of the identity and age of the Participant, which is two weeks after the deadline for the registration.
9. For the purposes of determination or defense against the claims the data will be stored until the limitation of the claims.
10. The legal basis of the processing of personal data is given consent (art. 6 act 1 l. a GDPR).
11. Your personal data will not be transferred to third countries/ international organizations.
12. Your personal data will not be processed by automated means.
13. You are entitled to bring an action to supervisory authority (President of the Office for Personal Data Protection).
